Facilities - Unity Outside Clean March 31 @ 8am-noon

Board came to consensus to spend no more than \$400. (\$443)

Sealing the driveway - Don got an estimate \$3800. Table for now.

Finance Team – Refinance update - Roberta

Capital and Contingency Fund- a set amount from what we're saving on our new mortgage to a fund for Capital/Contigency Fund Finance team recommends 500-1000?

Board agrees that some funds could go to a contingency fund every month. We'll ask for a recommendation from the finance team on a monthly basis.

Suggestion was made to commit to making two extra mortgage payments a year. When contingency fund is at 5,000, make a payment. When it reaches 10,000, make a second payment. Will revisit this when the refinance closes.
